**Grant applications:** 

VFA Grant: Hugh reported that applications are open for this 50% matching grant for wildland gear only. He

has been asking station captains about their needs. Bette suggested gloves.

El Pomar Grant-Boettcher Grant: Bette reported no progress.

**DOLA Grant:** Money has been awarded and is available for construction costs.

Refinancing/USDA Loan/ Station 4 Upgrade- First National Bank of Hugo has agreed to give the construction loan

with several fees included. Our attorneys are going over the details. The site needs a well first. Chief Collins will check

with the state on the status of the well application as it has been six weeks from submission. Today's *Coloradoan* 

posted the notice for bid requests for the project. A matrix for evaluating contractors has been done.

Chili Cook-Off- final results: With an additional \$5,000 donation, proceeds for the fundraiser were a little over

\$20,000.

**New Business:** 

De-Gallagherization -: Chief Collins gave an overview of the De-Gallagherization option available to rural fire

departments that requires a vote by the constituents in November. More information is needed as to what the other

mountain fire departments are doing. Greg and Bette suggested Hugh attend the Fire Chief's conference this summer

as the issue will be discussed.

Annual Audit: Bette reported that the audit draft has been received and that an adjustment will need to be made in

regards to the equipment depreciation.
